Subject to conditions prescribed by the University of California, Merced, responses to the University's prequalification documents for a General Contractor, Mechanical and Electrical subcontractor contract are sought from bidders for the following project:

### **KL3W Reconfiguration** UNIVERSITY OF CALIFORNIA, MERCED

#### **DESCRIPTION OF WORK:**

The project will provide space renovations to offices and support spaces located in the existing Kolligian Library Building 3<sup>rd</sup> Floor West on the UC Merced campus. The design will reconfigure spaces in the Kolligian Library 3<sup>rd</sup> Floor West, providing new administrative spaces. This project will reconfigure selected portions of approximately **15,500** assignable square feet of spaces while the remaining building and spaces are expected to be fully operational. The Work will include coordination with University furniture vendor, demolition of existing framed walls, frame new walls, doors & hardware, electrical modifications, HVAC and fire sprinkler adjustments, and finishes. The project is projected to be complete is August 2018 for start of fall semester.

#### **BIDDING SCHEDULE**

Following is the anticipated proposal schedule:

1. Bidding Documents available to prequalified bidders – June 1, 2018
2. Bids received and opened – June 21, 2018

For construction value between \$300,000 and \$640,000, Bidder and its mechanical, electrical and plumbing subcontractor(s) (if using) shall be qualified under the University's standards prior to award. Mechanical, Plumbing and Electrical subcontractors are required to complete and submit the prequalification documents.

The work described in the contract is a public work subject to section 1771 of the California Labor Code. This is a prevailing wage project.

No contractor or subcontractor, regardless of tier, may be listed on a Bid for, or engage in the performance of, any portion of this project, unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5 and 1771.1.

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations. Wage determination shall be per the first advertised date in accordance with the Department of Industrial Relations, prevailing wage.
