- A.** PRE-BID QUESTIONS – Questions received from bidders and responses are as follows:
1. Q. We would love to understand it a little more as we did not receive the earlier email (04/13) that you referred to in your email (05/03). In the interest of efficiency, can you guide us to next steps in the order of priority towards your May 11th deadline to submit our qualifications? is a reference to a deadline for today (05/05)?

**A.** All non-mandatory registration forms were due, May 5 which can be found in the Request for Qualifications. All registered firms will be notified of all addendums posted. Firms do not need to register to submit a Statement of Qualifications.
  2. Q. I reviewed the addendum that was sent out and do not see any changes JENSEN needs to make to our proposal based on the updates you sent over. do we still need to resubmit the proposal as I see us on the list of proposals that got "rejected due to administrative irregularities."? Can you please clarify whether or not you would like us to resubmit?

**A.** Statement of Qualifications received by April 27th do not need to be resubmitted unless there are any changes in the addendum that effect your Statement of Qualifications. If a firm does have changes, firm must reupload their Statement of Qualifications and note it as a revision.
  3. Q. We do not have a background in university projects, and I was wondering if this RFQ was sent in error. Is such experience a requirement? What about our firm moved you to reach out to us?

  4. Q. Will you be making a list of registered firms available? We are looking for teaming opportunities as a landscape architecture firm.
