I. Bidder acknowledges that it is the Bidder's responsibility to ascertain whether any Addenda have been issued and if so, to obtain copies of such Addenda. Bidder therefore agrees to be bound by all Addenda that have been issued for this bid.

This Addendum forms a part of the Contract Documents and modifies the original Bidding Documents. The following changes, additions, or deletions shall be made to the following documents as indicated and all other Contract Documents shall remain the same.

II. <u>CLARIFICATIONS</u>

- A. PRE-BID QUESTIONS Questions received from bidders and responses are as follows:
 - 1. Q. Will the fire sprinkler system be able to be isolated and completely shut off during construction? If so, will a fire watch be required from the local fire authority? (RFI001)
 - A. Fire Sprinkler system will not be able to be isolated from the rest of the building. 24/7 fire watch will be required to be performed. Those performing the fire watch are not to be performing any other work. Contractor to be responsible for coordinating fire sprinkler shut down and fire watch with the City, building occupants, and local fire authority.
 - 2. Q. Is Vapor-Alkalinity Control System required for this project? If so, please provide specification section 07 26 13 as stated under part 1.1.B.5 in section 09 68 40. Also, will there be 3rd party testing? (RFI002)
 - A. Vapor-Alkalinity Control system will be required. See specification section 07 26 13 added in Addendum 1. See Unit Price No. 1 in specification section 01 22 00 and on Bid Form added in Addendum 1. For more information on Unit Prices, Contractor is to reference part 7.5.1 of the General Conditions. Third Party testing will be required.
 - 3. Q. Is a "NON-COLLUSION STATEMENT" required to be submitted with the bid? (RFI003)
 - A. Statement of non-collusion is included in Section 13.0 Declaration of the Bid Form. No additional statement attached to Bid Form is required.
 - 4. Q. Please clarify if the following sections are part of this project? If so, please provide specification. (RFI004)

a. 03 20 00 – Rebar b. 07 60 00 – Sheet Metal c. 09-72-00 – Wall Covering

A. a. Specification section 03 20 00 - Reinforcing has been added by way of Addendum 1.

- b. There is no sheet metal, however, there is aluminum break metal that integrates with the Storefront. See details and revised specification section 08 41 00 part 2.2.G included with Addendum 1.
- c. There is no wall covering on the project.
- 5. Q. Specification Section 10 14 00 Signage; states this section to be bid under separate contract with the University. On sheet G100 note 2, it states to provide egress/accessibility signage. Is the contractor responsible for any signage? (RFI005)
 - A. Per Keynote 2 on sheet G100, signage to be furnished by University's separate contractor. Contractor is responsible for code identification signage. Wayfinding, ADA, and egress signage will be OFOI.
- 6. Q. On Bid form page 2 under Bidders Representation, it states if contract is awarded the bidder agrees to complete the proposed work within 80 days after the date of commencement. On Supplementary Instruction to bidders, it's 75 days. Please clarify. (RFI006)
 - A. Contract Time is 75 days per Supplementary Conditions. Bid Form has been updated to reflect 75 days.
- 7. Q. Specification Section 05 43 00 Slotted Channel Framing; is the Contractor responsible for structural calculations/design or the owner? (RFI007)
 - A. Contractor shall prepare and submit structural calculations prepared by a registered professional or structural engineer. See Addendum 1 revised specification section 05 40 00.
- 8. Q. As the [University] is supplying and installing the ACAMS system will they be providing the required Submittal Package, Labeling, Testing etc? If we are only providing cabling what do we need to supply in terms of submittals. Re the VSS System which model of Endura NVR is the [University] looking for on this project? Does there need to be a Local Viewing Work Station? If so what specifications do we need to meet? (RFI008)
 - A. Contractor is responsible for providing the labeling and testing for ACAMS as described in the Division 28 specifications; submittal requirements as specified in Division 28 of the bidding documents. Contractor to provide network interface with central Endura system as directed by University Representative. There is no Local Viewing Work Station; no additional specifications will be provided.
- 9. Q. Section 274116, 1.06, A lists a "Collaboration Space" but it is not detailed on the drawing E401 as to which room. Has this been deleted from the scope? (RFI009)
 - A. The Steelcase MediaScape Collaboration Space is shown on Sheet REF001 Preliminary Furnishing Plan that is added as part of Addendum No. 1. It is located in the northwest corner of Open Office 123-129.
- 10. Q. Section 274116, 1.06, B lists an AV system going into room 112 but there are no details for locations on the drawing E401. Did this get deleted from scope? (RFI010)
 - A. There is a Steelcase MediaScape table in Small Meeting Room 112 shown on Sheet REF001 Preliminary Furnishing Plan that is added as part of Addendum No. 1.
- 11. Q. Section 274116, 2.02, A says to provide equipment as listed. On all past UCM projects the AV equipment has been purchased by owner and id OFCI. Is it correct we are providing equipment this time? After section 274116, 3.10 the equipment is shown and there is a note in the comments section that states ALL equipment OFCI unless otherwise indicated. It is not indicated which, if any, equipment will be provided by the contractor. This looks like all equipment, hardware, and accessories are provided by OFCI. Please confirm. (RFI011)

- A. As noted in 274116, 2.02, D1 the equipment schedule is attached as an Appendix at the end of the section. The equipment schedule notes for the three listed locations "All equipment OFCI unless otherwise noted". As described in part of of this spec section the intent is for the Contractor to provide cable, wiring, connectors, plates, mounting and other materials for fully operational and integrated AV systems in part as described in 274116, 2.03.
- Q. Spec 084100 2.1.A.1.b calls for storefront for interior Type B frames. All Type B frames on windows schedule reference 081125 (aluminum knockdown) details. Are the interior frames storefront or knockdown? If knockdown please verify FG door types since spec 081125 does not include door specs. (RFI012)
 - A. All interior Storefront is to comply with specification section 08 41 00 type B. There is no reference to 081125 on sheet A700 Window Schedule.
- 13. Q. Please verify if E6 door is existing or a new door in existing frame. (RFI013)
 - A. Per the Door Schedule on Sheet A700, Door No. E6 is a new door in an existing frame. See revised Demolition Plan.
- 14. Q. [What] the deductible is on the University's Builder's Risk policy? (RFI014)
 - Please reference Exhibit 12 Summary of Master Builder's Risk Policy added in Addendum
 1.
