DESCRIPTION OF PROJECT:

The Site Development & Infrastructure project consists of several components of Work: 1) extending underground utilities, including chilled water, heated water, electrical and telecommunications duct banks along the Ansel Adams Road; 2) building a new Corporation Yard lay down yard, including fencing and a yard pad; 3) providing safety improvements at Scholars Lane; 4) building the new Rancher's Road and providing related site improvements; 5) providing additional cooling and power capacities to the Telecommunications Building; 6) providing a new RO system for the Cooling Tower and providing Pump House portable water system upgrades.
