### II. <u>CLARIFICATIONS</u>

  - Q. I haven't been able to locate any wall types or stud gauges on the exterior
    walls. I noticed that there was no spec section 5400 listed in paragraph 1.0 of
    the Drywall scope of Work nor did I read any mention of providing
    engineering. Please clarify.
    - A. Scope of Work 01 12 00.25 Drywall, Metal Studs & Insulation, paragraph 1.0, is revised per this Addendum to include Section 05 40 00. Provide engineering as specified in the project Bidding Documents.
  - 2. Q. Who's scope is responsible for furnishing and installing the .125 aluminum break shape sills shown on A8.30 details 1-5-6-7-9-13?
    - A. Scope of Work 01 12 00.23 Glass, Aluminum, Windows & Exterior Sun Control Devices. See subparagraph 3.20 in the scope of work.
  - 3. Q. Who's scope is responsible for furnishing and installing the .125 aluminum break metal shown on A8.20 detail 16/20?
    - A. Scope of Work 01 12 00.23 Glass, Aluminum, Windows & Exterior Sun Control Devices. (Paragraph 3.0 of the scope of work has been revised to add new subparagraph .21 per this Addendum.)

- 4. Q. There appears to be wood blocking below and alongside these sills. Who's scope is responsible for furnishing and installation?

- .7 Q. Please provide Specification Section 09 06 00.13 (Finish Schedule) as referenced on Sheet A4.10, General Note 10.

- 8. Q. Please confirm if the stone paving on page L5.01 is to be picked up by the Ceramic Tile scope of work #27 or the Site Concrete, Asphalt Paving and CMU bid package #15.
